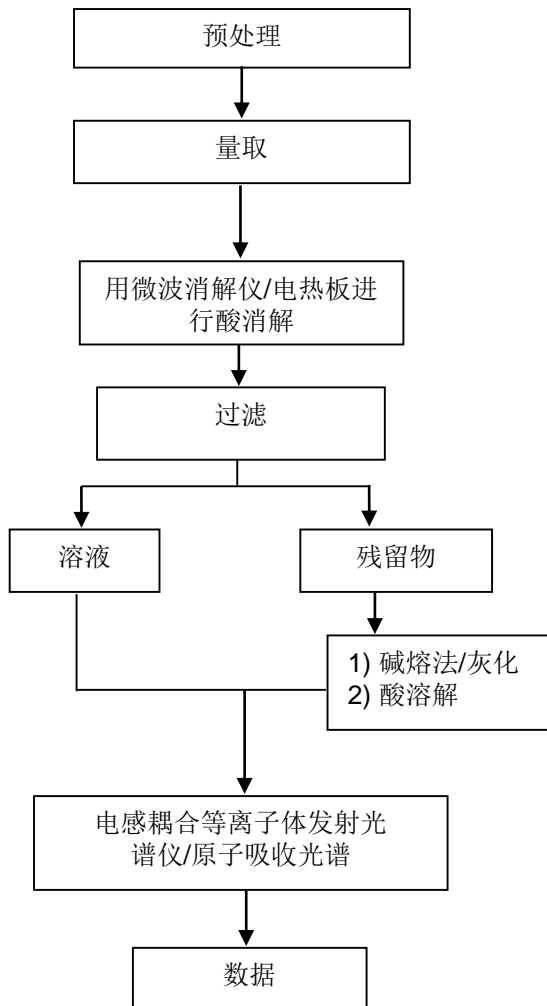

### 六价铬检测流程图



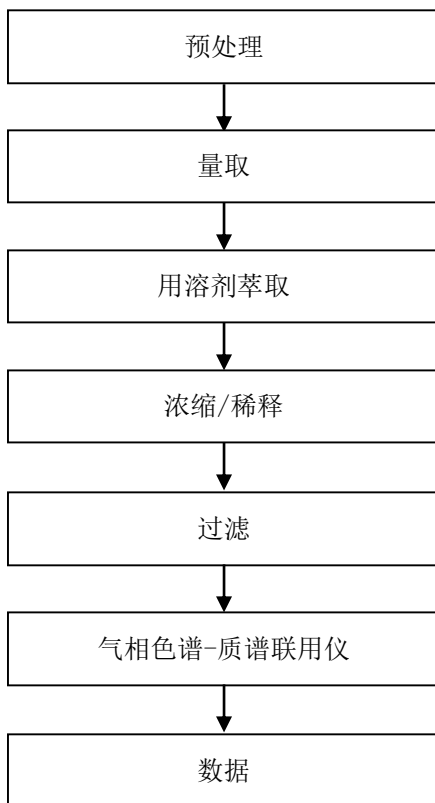

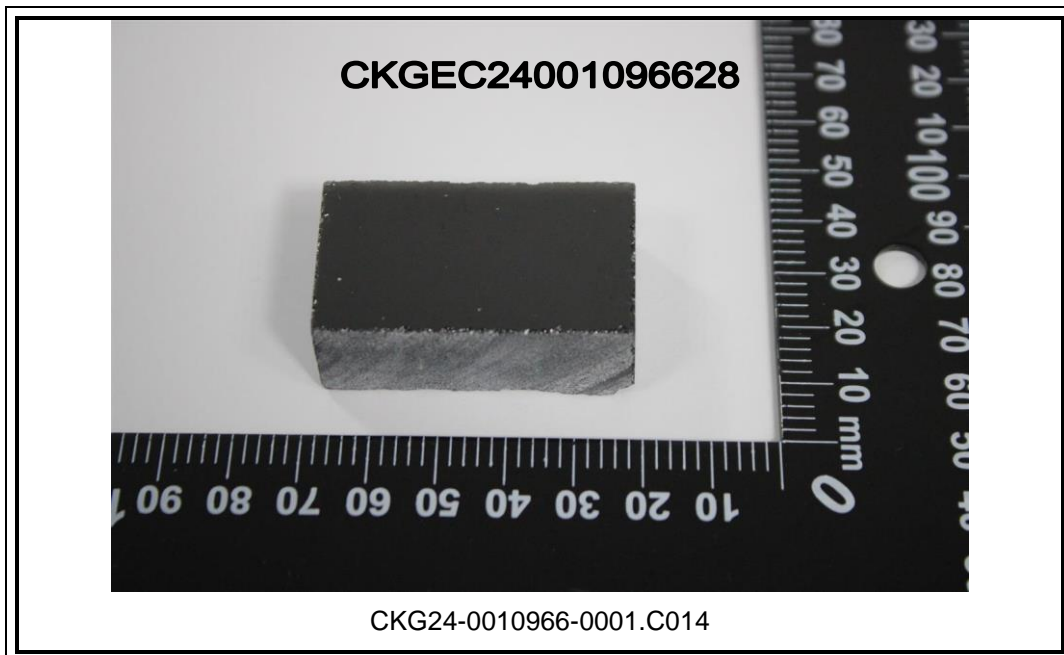
